Staff Summary:

Santos Omar Andino, 2201 Martin Luther King Jr. Drive, about the need for parking for his auto repair business that he has brought to North Chicago from Waukegan.

PZC Questions/Comments:

Question: A. Jackson asks how long Mr. Andino was in Waukegan.

Answer: Mr. Andino replies 9 years, 8 months.

Question: A. Jackson asks where the parking will be.

Answer: Mr. Andino replies at the back of the shop.

N. Warda mentions that Mr. Andino now also owns and lives in the house adjacent to the business.

Question: A. Jackson asks about parking for the house.

Answer: Mr. Andino replies that parking for the house will be accessible from the front of the house.

N. Warda mentions that the parking for the house is the space in between the two buildings, while the parking for the business will be in the rear.

N. Warda further clarifies that the rezoning of the three parcels is from R3 to CW.

Public Comments:

Sherman Swopes, 215 Oak Lane Winthrop Harbor, IL, received a registered letter and was confused why some other people he knows did not get the letter.

N. Warda explained that the letter was only sent to those property owners within 250 feet of the subject property.

Mr. Swopes was confused which property was the subject property.

N. Warda explained that it is the subject property just south and west of MLK Jr. Drive and Wright Avenue.

Mr. Swopes expressed his concerns with the state of the business at 2100 MLK Jr. Drive, which is on the north side of MLK Jr. Drive.
