Meeting attendees will have the opportunity to view a formal presentation (beginning at 5:00 p.m.) presented by the City's engineering consultant and participate in a live question and answer session with the project team. Interested citizens may ask questions and leave comments live during the meeting after the formal presentation. The project proposes modifying the existing cross section of Illinois Route 137 (Sheridan Road) from 10th Street to 15th Street. The roadway is proposed to be converted from four-lane to three-lanes with shoulders. The proposed improvements are scheduled to be implemented in conjunction with the planned IDOT resurfacing project in 2022. A Phase I Categorical Exclusion Project Development Report will be completed as part of this study.
