- VI. PUBLIC COMMENTS**

Carmecia Hawthorn

Ms. Hawthorn stated concern of removed stop sign at the corner of Kristan Ave. and Martin Luther King Jr. Dr. in front of TeePee store. She was concerned for the safety of the children and others. Mayor Rockingham explained that Martin Luther Jr. Dr. was owned and maintained by Lake County and North Chicago had no more jurisdiction over that road. The County decided that the children should cross the street at Lewis Ave.

Dora King & Amelia Gonzalez

Mayor Rockingham allowed extra time to speak due to the subject matter.

Mrs. King announced that the North Chicago School Board was returning to an elected Board of Directors. It had been 11-12 years since the last elected Board. She thanked the Mayor for his participation in the efforts. Starting in 2025 the Board would be elected. She invited everyone to “a celebration and support of the District’s transition to an Elected School Board” March 19th, 6-7 p.m. at North Chicago High School. Ms. Gonzalez interpreted in Spanish.

Alderman January entered the Council Chambers at 6:12 p.m.

District 187 School Superintendent Price elaborated that there was intention to build a net zero energy efficient project at Forrestal School by way of grant monies. He appreciated the North Chicago staff with all their assistance. Planning for more students once the project is complete because the school would be bigger. Alderman Allen asked how more students would be allowed to attend. Mr. Price explained that if the student has an address in North Chicago, they would be able to attend that school.

Mayor Rockingham expressed his appreciation for Mr. Price's efforts toward the betterment of North Chicago. He also thanked Mrs. King and Ms. Gonzalez.

Bryan Oglesby

Mr. Oglesby concerned with litter along Lewis Ave. between Audrey Nixon Boulevard and 16th Street. He contacted Alderman Allen about the Dollar store that has all the garbage outside. He also mentioned the problem with graffiti. Alderman Allen thanked him for addressing the City Council and promised that the area would be cleaned up. Alderman January also appreciated him bringing to the City.
