VI. PUBLIC COMMENTS

Rita Turman and Amias Turman

Mrs. Turman gave a statement of their property being taken by the City including \$100,000 construction money. She felt the City's approach was aggressive and punitive; no one deserved to be treated that way.

Mr. Turman explained he and his wife were lifelong residents of North Chicago and married 40 years. After the news about the taking of the property he contacted the Mayor, Alderman Allen and Alderman Smith. When he spoke to the Mayor, he was told it was a City Council decision, Alderman Allen referred him to Chief of Staff of less than a year and was not answered by Alderman Smith. He referenced the Tulsa massacre relating to a predominantly black community taking his property and money. He noted that he had also previously worked for the City.

Kejuan Hodge

Mr. Hodge thanked the Council for approving his business at the previous Council meeting (1611 Audrey Nixon Blvd.)

Dora King – President Independent Authority

She asked for volunteers to post banners in their yard or major areas to notify and prepare for the elected School Board in 2025. The

John Price – Superintendent of North Chicago Community School District

He firstly thanked the City for the Police and Fire Department, especially with their growing relationship with the school. He gave an overview of all the many projects going on in the school district. Highlighted demolishing and replacing the tennis courts, strong growth in academic testing and awarded 25 full-ride scholarships of 2024 class to attend College of Lake County through North Chicago Education Foundation.

Mayor Rockingham congratulated him on the number of high school graduates; Dr. Price said 191 crossed the stage. Alderman Smith asked how many of the graduates were attending CLC; Dr. Price said last year was 55 but did not have final numbers yet. Alderman Smith suggested getting that number. Alderman Evans offered to have a banner placed in his yard.
