- VI. PUBLIC COMMENTS**

- 6-1 Know Your Rights Presentation by the North Chicago Community Think Tank

Rayon Edwards

Thanked the Mayor for the Executive Order against ICE. He disagreed with the actions taken against former Alderman Kenneth Smith for one incident. He acknowledged City Treasurer Vance Wyatt for being present.

Superintendent John Price – School District #187

Thanked the Mayor for the Executive Order. Federal actions have affected the community and instilled fear of doing their daily activities. Thanked the City for exemptions for the South School project.

Mr. Price stated the School District had for years attempted to reach a contract with L.E.A.R.N. Charter School and they refused. District #187, in 2025, tried again to negotiate but several areas still lacked agreement. Alderman Allen asked the next meeting of the 2 schools, to hear both sides; Dr. Price said there was no meeting set possibly because of Federal Government shutdown.

Alderman Brooks asked if there would possibly more North Chicago public schools. Dr. Price said that would be a possibility. Alderman Coleman was information that the elected School Board was reluctant to agreement and that was the City's voice, both sides needed to be heard.

Mayor Rockingham thanked Dr. Price for his work in the School District. He would like to also hear from L.E.A.R.N.

Dulce Ortiz – Executive Director of Mano a Mano

Stated Mano a Mano serviced all of Lake County. Appreciative of Executive Order. ICE was performing unlawful arrests and kidnapping.

Fiestas Patrias

ICE was performing acts against not only immigrants but citizens and voters and not just criminals. The operatives were a violation of constitutional and human rights. Commended the Mayor to take the lead with an Executive Order. She also recognized Alderman Jackson; she asked for his insight because he also worked for Homeland Security of Lake County.

Carmecia Hawthorne

Announced events of Foss Park.

6-1 Know Your Rights Presentation by the North Chicago Community Think Tank

Alderman Coleman left the Council Chambers at 6:33 p.m.; returned at 6:34 p.m.

Mayor Rockingham explained that the presentation was to attempt to inform people that may be approached or detained by ICE, including people that were legal.

William "Billy" Coleman of Think Tank said many people do not know their rights. The training was developed with many organizations within Lake County.

The Know Your Rights Program outlines: Why the conversation is important, what's happening, your rights, how to stay protected (1st and 5th amendment), some next steps and ways to help. By the end of the training, you will know: current political moment, legal rights and risk, realistic safety strategies, localized next steps and ways to help.

He highlighted that White Supremacy and Slavery have never been abolished. The 13th Amendment states that slavery has not been abolished except in cases when someone has been convicted of a crime. Mass Deportations / Incarcerations have happened before. Violence is all around and the "Big Beautiful Bill" would be reviewed in the training.

Mr. Coleman announced that the North Chicago Think Tank meetings were every Tuesday at the North Chicago Public Library, 6:00 p.m. He requested every alderman to contact him to schedule a time for the Think Tank to present in their ward.

Alderman Coleman thanked Billy Coleman for the work that he had done in the community, Alderman Allen also thanked him. Alderman Brooks recognized Mr. Coleman and encouraged the other aldermen to talk to him. Alderman Evans was appreciative for his work and presentation.

Mayor Rockingham hoped the community would participate in the Think Tank training and meetings; he thanked him for all his work. Alderman Jackson asked how long the training was; Mr. Coleman said 60 minutes in person or virtually.
