VIII. MISCELLANEOUS BUSINESS

Alderman Evans clarified that the City was trying to re-brand and needed to hire more residents from within North Chicago ensuring correct decisions including the Mayor as one moving the city forward.

Chief of Staff Greg Jackson explained the IEPA Sheridan Crossing Remediation. The RFP (Request for Proposal) opening was the following day. The City had received a release from IEPA, nearing the closing of the land conversion for the water tower project once secured additional funding. He noted that North Chicago was featured in a national magazine and the magazine was utilized for recruiting businesses.

Alderman Coleman explained the job openings, ribbon-cutting ceremony of (3 parks and he expressed his excitement. With Community Days approaching, he asked if the Park District staff received enough Community Days t-shirts. He asked if fliers were also placed in the Aldermanic mailboxes.

Alderman Brooks stated he brought the students from Neal Math & Science Academy to various parks which they enjoyed. He acknowledged those involved with the park development.
